

Proposed Revision PIA-C-5646B 01 May 2003

Superseding PIA-C-5646A 08 June 2002

The following commercial specification is originally adopted from the military documents. Revision A included all known accepted revisions, amendments, notices, and Department of Defense (DoD) engineering changes previously developed for this item. Revisions B and forward include changes adopted by DoD and industry to reflect technology and design evolution.

## **CLOTH, AIRPLANE**

The Parachute Industry Association makes this document available for use by Industry and Government organizations that wish to apply this specification to their products.

#### 1. SCOPE

1.1 <u>Scope</u>. This specification covers mercerized cotton cloth intended for use in the integral surface coverings of airplanes, as a base for a modified butyl rubber coated cloth, and in military personnel and cargo parachute systems.
